



PGHS Reopening Overview 2020-2021

Pacific Grove High School has taken many recommendations into consideration when designing reentry models. Every aspect of these plans follows state and county guidelines regarding physical distancing to keep all staff and students safe as we return to school and Senate Bill 98. PGHS administration held numerous meetings with staff and the school community to seek input in the development of a hybrid and distance learning model. In addition to input meetings, surveys were also administered. The results are listed at the bottom of this document.

1. The first day of school will be August 12, 2020.

2. PGUSD will take a three-tiered approach to reopening schools in August, beginning the school year with distance learning.

3a. & 3b. PGHS Alternative Schedule Model - Distance Learning Model (To be applied during Tier#1) and Hybrid Learning Model (To be applied during Tier #2). In the event, we must revert back to Tier#1 and/or Tier#2 at any time during the course of the 2020.2021 school year the Alternate Schedule Model will allow for a seamless transition with minimal disruption between the DISTANCE LEARNING Model and the HYBRID Model.

1. & 2.

First Day of School / Three-Tiered Approach to Reopening:

Based on the review of Monterey County Health information and cases, review of procedures with County Health Department and discussion with neighboring school districts, the administration recommends a tiered approach to the 2020-21 PGUSD school year (*all dates listed are target dates and may change depending on current data):

Tier #1: August 12, 2020 - October 19, 2020 (end of Fall break)

- Distance Learning for all students initially
- Limited on-campus in-person learning opportunities for identified students in small
- groups with physical distancing and all mitigation measures in place
- Implementing clear expectations from the State/District regarding distance learning and accountability
- Childcare provided for staff children (TK-8), at a reduced rate, who are required to work from sites
- Gradual return to Hybrid learning models (as presented) pending data that suggests a safe return and that measures can be met in the community

Tier #2: October 19, 2020 – January 5, 2021 (end of winter break)

- Hybrid models implemented District-wide, as presented in Re-Open plans and adjusted for the current situation, with all recommended protocols in place
- Maintain Distance Learning option for families that require it, based on any new guidelines initiated by State/Local agencies
- Limited on-campus in-person learning opportunities for identified students in small
- groups with physical distancing and all mitigation measures in place
- Childcare provided for staff children (TK- 8), at a reduced rate when children are not at school
- Return to full-time in-person learning model as data and science suggest safety
- measures can be met in the community, or ordered to do so by State
- Pending data, information and directives from State and County governments it may be necessary to return to tier 1 procedures

Tier #3: January 5, 2021 - June 2021 (end of the calendar year)

- Return to full-time in-person learning based on data and science with all recommended protocols in place
- Maintain Distance Learning option for families that required it, based on any new guidelines initiated by State/Local agencies
- Continue to monitor data and adjust model according to data and health professional guidance
- Pending data, information and directives from State and County governments it may be necessary to return to tier 2 or tier 1 procedures
